# MoSPI Releases the National Industrial Classification (NIC) - 2025

The NIC is a fundamental tool for statistical surveys, censuses, economic research, and policy formulation.

National Industrial Classification (NIC) – 2025

- ▶ NIC 2025 updates the previous NIC 2008. (It was first introduced in 1962).
- It was prepared by MoSPI in alignment with the International Standard Industrial Classification of All Economic Activities (ISIC) Revision 5 developed by the United Nations Statistics Division (UNSD).

### **Major Changes**

- Structural Change: It moves from the 5-digit coding structure of NIC 2008 to a new 6-digit coding structure. It allows for greater granularity and flexibility, enabling better representation of emerging activities.
- ▶ Recognition of indigenous sectors such as Ayush-based healthcare and the handloom industry.
- **▶** It also includes sectors like renewable energy, fintech, e-commerce, and digital intermediation.

#### **Salient Features of NIC 2025**

- ▶ Enhanced Classification of Intermediation Services: New classes have been created to reflect the growing role of intermediaries in sectors such as power, retail, logistics, healthcare, and education.
- ➤ Representation of Digital Economy: Cloud infrastructure, blockchain, platform-based services, and web search portals are distinctly classified.
- ▶ Integration of Environmental and Green Economy: Expanded coverage includes activities related to carbon capture, waste management, and environmental remediation, better aligning with SDGs.
- Classification is technology agnostic: It means distinctions of activities are not made based on whether an activity is carried out by means of traditional or modern production techniques.

# Government introduces new modalities under PMFBY to strengthen farmer protection

Revised framework for Pradhan Mantri Fasal Bima Yojana (PMFBY) will be rolled out from Kharif 2026.

#### **Key Changes introduced under PMFBY**

- New Coverage Added: Crop loss due to wild animal attacks is included as the 5th add-on cover under localised risks.
- ▶ Reintroduced Protection: Paddy inundation restored as a localised calamity cover (removed in 2018).
- > State-Level Identification: States will notify the list of wild animals and vulnerable districts based on historical data.
- Mandatory Reporting: Farmers must report losses within 72 hours via the crop insurance app with geo-tagged photos.

### **About PM Fasal Bima Yojana (PMFBY)**

- ▶ Ministry: Launched in 2016 by the Ministry of Agriculture & Farmers' Welfare.
- > Type: Central Sector Scheme
- Aims & Objectives:
  - Financial support to farmers suffering crop loss/ damage, stabilizing their income and ensuring flow of credit to the agriculture sector.
  - Adoption of innovative & modern agricultural practices and crop diversification.
- **▶ Eligibility:** Farmers, including sharecroppers and tenant farmers, growing notified crops in notified areas.
- Premium Payable by Farmers:
  - **⊙** For Kharif crops 2%
  - **⊙** For Rabi crops 1.5%
- ➤ Premium by Government: Shared equally (50:50) by the Central and State Governments; Except for North-Eastern and Himalayan states (90:10).

# Multiple Digital Initiatives launched to modernise warehousing and boost PDS Transparency

Union Minister of Consumer Affairs, Food & Public Distribution launched major digital initiatives to modernize warehousing operations, improve supply chain efficiency and enhance transparency across the Public Distribution System (PDS).

Initiative	Details Details
Bhandaran 360	Introduced by Central Warehousing Corporation (CWC), it is a cloud-based ERP platform which integrates HR, finance, warehouse management, contract monitoring etc.
	▶ <b>Benefits:</b> real-time monitoring of warehouse operations, Standardization across all CWC warehouses.
Smart EXIM Warehouse System	CWC has introduced the Smart EXIM Warehouse System for container freight stations (CFS/ICD) and general warehouses.
	It uses technologies like AI, IoT, FASTag, OCR/ANPR, and GNSS to automate key processes.
	Benefits: Gate Automation and Yard Management, cargo tracking., Smart Inventory Management.
ANNA DARPAN	Introduced by FCI, it is a new microservices-based (mobile-first) platform that replaces the existing Depot Online System.
	It integrates procurement, storage, movement, sales, labour & procurement enabling real-time dashboards and faster decision-making across the food supply chain.
ASHA Platform	> The Department of Food and Public Distribution has launched ASHA, Anna Sahayata Holistic Al Solution.
	It is an AI-based platform that allows beneficiaries to share their feedback on ration distribution through AI enabled calls in their preferred language.

## Significance

- Supports Government's mission to reduce logistics cost, minimize turnaround time and strengthen supply chain efficiency.
- Promotes integrated logistics ecosystem under PM Gati Shakti.
- Ensures accurate, faster, dignified delivery of subsidized foodgrains.

# SC recalls judgment striking down ex post facto environmental clearances

The Vanashakti judgment had previously barred the granting of ex-post-facto environmental clearances (EC).

Under Vanashakti Judgment, court had struck down a 2017 notification and 2021 Office Memorandum (OM) of **Centre**, which in effect recognised the grant of ex post facto ECs.

#### Reasoning for Recalling the Vanashakti Judgment

- > Legal precedents ignored: CJI observed that the Vanashakti judgment was rendered without taking notice of previous judgments of coordinate benches, thus rendering it per incuriam.
  - E.g. D Swamy vs Karnataka State Pollution Control Board (2021) held that post-facto EC can be granted in exceptional cases.
  - discouraging post-facto EC, had regularized existing post-facto ECs with directions to pay monetary penalties.
- **Economic costs:** Adhering to the Vanashakti ruling would lead to the demolition of completed public projects.
  - pollution e.g. debris, reconstruction emissions etc.

### **About Ex-Post Facto Environmental Clearance**

- ➤ An ex-post facto EC essentially allows a project proponent to continue with its project without obtaining an EC prior to project commencement.
- Environmental **Impact** Assessment **clearance**' before a project can start.
- Notification, 2006, clearly requires 'prior environmental

#### **Environmental Clearance (EC) in India**

EC is required in India for projects that can significantly impact the environment.

- ➤ EIA Notification, 2006 lists over 39 types of activities (mining, infrastructure, power plants, etc.) that need EC prior to start of a project.
- Categorization of Projects:
  - under the EIA Notification.
    - Category A projects: Considered at the Central level in the Ministry of Environment, Forest & Climate Change (MoEF&CC)
    - Category B projects: Handled at the State level by the State/UT Environmental Impact Assessment Authority (SEIAA).
- Previously, in Common Cause v. Uol & Ors. (2017), Supreme Court held that the concept of ex post facto or retrospective environmental clearance is completely alien to environmental jurisprudence.







### National Action Plan on Antimicrobial Resistance 2.0 launched

The Union Minister launched the second version of the National Action Plan on Antimicrobial Resistance (NAP-AMR) (2025-29).

#### **About NAP-AMR 2.0**

- ▶ It builds upon the gaps identified in the first National Action Plan (2017–2021) and aligns with the Global Action Plan on AMR by the WHO.
- It includes specific action plans of each key stakeholder ministry/department with timelines and budget to enable effective monitoring of progress in implementation.
- Kev strategies:
  - Increasing the ownership of AMR-related efforts and Well defined mechanisms for strengthening inter-sectoral coordination.
  - Enhancing laboratory capacity and infection control in healthcare facilities.

## **About AMR and Impact of AMR**

- Antimicrobial Resistance (AMR) occurs when microorganisms such as bacteria, viruses, fungi, and parasites evolve mechanisms to resist the drugs designed to kill them.
- Impact:
  - Global Health Threat: It is associated with around 4.95 million deaths a year globally and 1.27 million deaths are directly attributed to it.
  - Higher Healthcare Burden: Ineffective treatment leads to increased healthcare costs for families.
  - Growth and Economy: AMR weakens productivity and increases financial losses, threatening national and global economic development.
  - Delays in Treatment: Resistance to antimicrobial medicines causes delays in effective treatment.
  - Others: Food production, Threat to Medical Procedures, Reversal of Medical Progress.

## **Base Effect**

As per some economists, Inflation rate in India has fallen low due to various reasons including a highly favourable base effect. **About Base effect** 

- **Definition**: The base effect refers to the impact of the reference point (base year/month/data point) used for comparison on the outcome of ratio or percentage-based indicators.
- ▶ It can distort trends if the base period had abnormally high or low values.
- Uses: To calculate Inflation data (CPI/WPI), GDP growth rates, etc.

Objective: To deliver transparent, accessible trade **intelligence** that supports businesses and strengthens evidence-based policymaking.

## **Key Features**

- > FTA Utilization: Improves the effective use of trade agreements by exporters.
- Country and commodity intelligence tools help identify focus products for each market.
- **▶** Efficiency: Replaces old fragmented portals with a unified, scalable system.
- **Empowerment:** Helps small and remote businesses access clear market insights



## **Climate Change Performance** Index (CCPI)

Recently, CCPI was released which compares climate performance of 63 countries and the EU, which together account for over 90% of global GHG emissions.

### **About Climate Change Performance Index (CCPI)**

- > Published by: Germanwatch, NewClimate Institute & Climate Action Network (CAN).
- Ranking:
  - None of the countries are in the top 3.
  - Denmark: 4th, followed by UK & Morocco.
- > It measures climate mitigation performance in four categories of GHG Emissions, Renewable Energy, Energy **Use and Climate Policy.**

#### **Findings for India**

- ▶ India ranks 23rd, going from a high performer to a medium one in this year's CCPI.
- ➤ There is no national coal exit timeline and new coal blocks continue to be auctioned.
- **Key demands:** Time-bound coal phase-down and eventually a phase-out and redirecting fossil subsidies decentralised, community-owned renewable toward energy.











# **Codex Alimentarius Commission**

India has been re-elected to the Codex Executive Committee for the Asia region at the 48th Codex Alimentarius Commission (CAC48).

#### **About Codex Alimentarius Commission**

- **▶ Genesis:** Intergovernmental body established jointly by the FAO and WHO in 1963.
- **Objective:** Protecting consumer's health and ensuring fair practices in the food trade.
- ➤ Membership: Open to all Member Nations and Associate Members of FAO and WHO interested in international food standards.
  - Current Members: 189 (188 Member Countries (Including India) and 1 Organization i.e. EU).
- Meetings: Convenes annually, with sessions alternating between Geneva and Rome.



#### **National Water Awards**

In the category of best state, Maharashtra has been ranked 1st, followed by Gujarat and Haryana under 6th National Water Awards (2024).

#### **National Water Awards**

- Instituted by: By Department of Water Resources, River Development and Ganga Rejuvenation, Ministry of Jal Shakti
- ➤ Aim: To create awareness among people about importance of water and motivate them to adopt the best water usage practices.
- > Presented in 10 categories: Best State, Best District, Best Village Panchayat, Best Urban Local Body, Best School or College, Best Industry, Best Water User Association, Best Institution (other than school or college), Best Civil Society and Best individual.



# **Gaza Peace Plan**

The UN Security Council has approved a US-backed Gaza peace plan.

#### Gaza Peace Plan

- ➤ Proposed framework to end the Israel-Hamas conflict through ceasefire, humanitarian relief, governance reform, and reconstruction.
- ➤ The Gaza Peace Plan was primarily brokered by the United States, with mediation support from Qatar and Egypt.

## **Kev Features**

- ➤ Ceasefire Mechanism: Immediate, internationally monitored halt in hostilities to stabilise Gaza.
- > Hostage-Prisoner Exchange: Mutual release of hostages (Hamas) and detainees (Israel).
- > Other Features: Governance Reform in Palestine, deployment of an international stabilization force etc.



# **Bot Mitigation Systems**

A technical outage at Cloudflare, triggered by a latent bug in its bot-mitigation system, led to significant global service disruptions, affecting platforms such as X and ChatGPT.

# **About Bot-Mitigation System**

- ▶ Bot mitigation is the task of blocking bad bots or botnet activity from accessing websites, servers, or IT
  - ⊕ Bots are automated programs, some aid tasks like indexing, while others steal data, spread spam, or trigger Distributed Denial-of-Service (DDoS) attacks.
- Techniques: Relies on behaviour patterns, IP checks, CAPTCHA, and ML tools.

## Guru Tegh Bahadur ji

- He was born in Amritsar (Punjab).

#### **Kev Contributions**

- ➤ He founded the town of Chak Nanki in Punjab, later enlarged into the city of Shri Anandpur Sahib.

- He propagated the message of universal brotherhood and religious
  - ⊕ He fought against superstitions, caste- based discrimination, and
