The 1st Assembly of International Big Cat Alliance (IBCA)

The 1st assembly of the IBCA convened in New Delhi, endorsed the India's Union Minister of Environment, Forest & Climate Change, Shri Bhupender Yadav, as the President of IBCA.

> The Assembly of the IBCA serves as its apex decision-making body and is convened at least once every 2 years.

About IBCA

- It is a multi-country, multi-agency coalition of 95 big cat range countries, non-range countries with an interest in big cat conservation.
 - These Big Cats include Tiger, Lion, Leopard, Snow Leopard, Cheetah, Jaguar & Puma. (refer to table)
- Genesis: Launched in April 2023 (occasion of 50 years of India's Project Tiger)
- Main Goal: To foster collaboration and synergy by establishing a platform dedicated to sharing best practices in big cat conservation.
- Founding Members (16): Armenia, Bangladesh, Bhutan, Cambodia, Egypt, Ethiopia, Ecuador, India, Kenya, Malaysia, Mongolia, Nepal, Nigeria, Peru, Suriname, & Uganda.
- India is the host country & Secretariat for the IBCA.
- Significance of protecting big cats & their habitats
- Protects Biodiversity: As Keystone species big cats balance ecosystems and safeguard biodiversity.
- Climate Change Mitigation: Protecting big cat habitats safeguards forests, water sources, and carbon sinks, aiding in climate change mitigation.
- > Supports economy: Providing livelihood opportunities and promoting ecotourism.

The 113th International Labour Conference (ILC) Concluded in Geneva

The International Labour Conference is the annual meeting of the International Labour Organization. **Key Highlights**

- Adopted Biological Hazards in the Working Environment Convention, 2025 (Convention No. 192): The 1st international instrument specifically addressing biological hazards in the working environment.
- Approved Amendment to Maritime Labour Convention, 2006 (MLC): The changes call for the right to shore leave and repatriation, and call for recognizing seafarers as key workers.
 - MLC is a binding international law for ensuring minimum working and living standards for all seafarers on ships. India ratified the MLC in 2015.
- Decent Work in the Platform Economy: It held its 1st standard-setting discussion on decent work in the platform economy, an important step toward improving rights and conditions for digital platform workers.
- Resolution on Reducing Informality: ILC adopted a Resolution to reduce informality and support the transition to formal work.
- The resolution calls for urgent action to improve working conditions, extend social protection, and create decent jobs, especially for those most affected by informality.
- Other: Formal approval was given to the ILO's tripartite contribution to the Second World Summit for Social Development, set for November 2025 in Doha.

Global Coalition for Social Justice

- The 2nd edition of the Global Coalition for Social Justice annual forum took place on the side lines of the 113th ILC in Geneva.
- It is an initiative of the ILO, launched in 2023. It aims to bring together global, regional, and national actors to advance social justice through policy and action coherence.





Stockholm International Peace Research Institute (SIPRI) Yearbook 2025 Warns of a New Nuclear Arms Race

Key Findings

- Global Nuclear Stockpile Decline: Since the end of the Cold War, the number of retired warheads has exceeded new deployments.
- Countries Expanding Stockpile: China is expanding fastest, > with its stockpile now at least 600 warheads.
 - India's arsenal increased from 172 to 180 warheads, more than Pakistan's (170).
- Modernisation: In 2024, all 9 nuclear-armed countries continued to modernise their arsenals.
- Status of Fissile Materials: The explosive material utilized in nuclear weapons is fissile material, either highly enriched uranium (HEU) or separated plutonium.
 - China, and Pakistan have produced both HEU and plutonium for use in their nuclear weapons.
 - India and Israel have produced mainly plutonium.

Emerging Threats:

- Over Modern Technologies: The rapid development of artificial intelligence (AI), cyber capabilities, space assets, missile defence and quantum are radically creating potential sources of instability.
- Arms control in crisis: While New START remains in force until early 2026, there are no signs of negotiations to renew or replace it.

DRDO & IIT Delhi Achieve Quantum Entanglement-Based Free-Space Communication

The free-space quantum secure communication was demonstrated over a distance of ~1 km via a free-space optical link.

ISRO demonstrated 1st free-space QKD over 300m in 2021.

About the experiment

- It was part of the 'Design and development of photonic technologies for free space Quantum Key Distribution (QKD)' of DRDO. >
- The experiment exhibited a very low quantum bit error rate (QBER) of less than 7%. >
 - QBER is the error between the information sent and received and an indicator of the probability of eavesdropping.
- It paves the way for real-time applications in quantum cybersecurity, long-distance QKD, and the future quantum internet.


What is QKD?

- **Communication Technology:** It is a Quantum > Communication technology based on quantum mechanics, that is, quantum entanglement and cryptography.
 - Quantum mechanics explains how extremely small objects simultaneously have the characteristics of both particles and waves (a disturbance or variation that transfers energy).
 - Physicists call this the "wave-particle duality."
- **Key Principles:**

- Quantum entanglement: Particles of the same origin, which were once connected, always stay connected, even when separated by vast distances.
- Output of the secure and transmit data in a way that cannot be hacked.

Benefits of Entanglement-Based QKD

- Functionality: Secure key distribution even if devices are compromised or imperfect. >
- Detection of eavesdropping: Any attempt to measure or intercept the entangled photons disturbs the quantum state. >
- Free-space QKD: No need for expensive fibre-optic cables—ideal for tough terrain and dense cities.

The Prime Minister of India Visits Cyprus after 23 years

- During the visit both countries signed a Joint Declaration on the implementation of the Comprehensive Partnership.
- > The Indian PM was also conferred with Cyprus' highest civilian honour, the 'Grand Cross of the Order of Makarios III'.

Key Highlights of the Joint Declaration

- Both countries reaffirmed their support for a rules-based international order, grounded in the UN Charter.
- Both expressed their strong commitment > to the resumption of UN-facilitated efforts to achieve a comprehensive & lasting settlement of the Cyprus Question.
- Cyprus expressed strong support for India against cross-border terrorism, condemned the recent Pahalgam terrorist attack.

Significance of Cyprus for India

- To counter the growing Turkey-Pakistan axis & support India's broader strategy to isolate Pakistan diplomatically.
 - Turkey supported Pakistan on Kashmir issue, and backed Pakistan during **Operation Sindoor.**
- Gateway to Europe: Cyprus forms part of > the energy corridor & strengthens East-West connectivity through India-Middle East-Europe Corridor (IMEC).
- FDI: Cyprus is among the top 10 investors in India with cumulative investments of USD 14.65 Billion during 2000 2025.
- Enhanced India-EU Relations: As Cyprus is set to hold the rotating presidency of EU Council in 2026. Cyprus can play a pivotal role in advocating for India's interests within the bloc.
- Other: Supports India for permanent seat at UNSC, Nuclear Suppliers Group etc.

Cyprus Question/Problem

- Cyprus is an island in the eastern Mediterranean Sea, located close to Turkey and Syria.
 - It is a member of the European Union (EU) despite being geographically in Asia.
- It got independence from the British in 1960; however Since 1974 Cyprus has been divided between Turkiye-backed Northern Cyprus and Republic of Cyprus. It is known as Cyprus Question/problem.
- India supports a bi-zonal bicommunal federation based on UN Resolutions as a solution to the Cyprus problem.

The Registrar General of India, under the Ministry of Home Affairs, has notified that the Census will be held in 2027.

The notification was published under the Census Act, 1948. >

Key Highlights of Census 2027 >

- To be conducted in 2 phases:
 - Phase I House Listing (HLO)
- Phase II Population Enumeration (PE)
- Include Caste enumeration as well.
- Conducted through digital means, using mobile applications.
- Provision of self-enumeration would also be made available to the people.

- About Cyber Suraksha Exercise > lt is a comprehensive Cybersecurity Exercise to bolster national cyber resilience.
- The exercise is designed to simulate real-world cyber for providing threats. targeted training sessions.

WHA Resolution on Skin Diseases

The World Health Assembly (WHA) of WHO unanimously passed a resolution titled "Skin Diseases as a Global Public Health Priority." About the Resolution

- Need:
 - Widespread Impact: Skin diseases affect 1.9 billion people alobally.
 - € Neglected Area: Often underfunded and overlooked, especially in low- and middle-income countries.
- Supported by: International League of Dermatologic Societies (ILDS), the world's largest dermatology alliance.
- Key provisions
 - Provides for Global Action Plan to establish a framework for Prevention, Early detection, Effective treatment, Long-term care of skin diseases.
 - 0 Calls for dedicated health investment,
 - \odot Supports expansion of research, surveillance and data collection.

TRAI releases Telecommunication Tariff Order 2025 on Tariff for retail broadband connectivity for PDOs under PM-WANI Scheme. About Prime Minister's Wi-Fi Access Network Interface (PM-WANI) Scheme

- It was launched by the Department of Telecommunication in > 2020.
- Aim: To enhance the proliferation of public WiFi hotspots to create robust digital communications infrastructure in the country, especially in rural areas.
- The scheme encourages local shops and establishments to provide Wi-Fi for last-mile internet delivery.
 - They do not require a license or charge a registration fee.

Dharti Aaba Janbhagidari Abhiyan

Ministry of Tribal Affairs launches Largest Tribal Empowerment Campaign.

About Dharti Aaba Janbhagidari Abhiyan

- Under it, nationwide benefit saturation camps are being > conducted at the village & habitation level to provide access to critical entitlements and government services.
- E.g. Adhaar Card Enrolments and Updates.
- It is a key initiative under Janjatiya Gaurav Varsh, which honors the legacy, culture, & contribution of India's tribal communities.
- It embodies the principles of last-mile delivery, people's participation (Janbhagidari) & dignified tribal empowerment under the larger umbrellas of PM-JANMAN and Dharti Aaba Janjatiya Gram Utkarsh Abhiyan.

Samarth Program

The Centre for Development of Telematics (C-DOT) provided grants to 18 startups under its 'Samarth' Program.

- C-DOT is the Telecom R&D centre of the Department of Telecommunications, Ministry of Communications. > **About Samarth Program**
- It is a cutting-edge Startup Incubation Program of C-DOT for development of India's telecommunications & IT sectors.
- It aids in access to Startup grants (up to 5 lakh/ startup), world-class infrastructure, expert mentorship, networking etc.
- Implementation Partner: Software Technology Parks of India (STPI) & TiE (The Indus Entrepreneurs). STPI is a premier S&T organization under Ministry of Electronics and Information Technology (MeitY).



Switch Auction

In a government switch auction conducted for a notified amount of ₹25,000 crore, the Reserve Bank of India (RBI) accepted approximately ₹ 9,000 crore.

About Switch Auction

- Genesis: Began in 2019 by the RBI on behalf of the Government > of India.
- Objective: To manage the maturity profile of public debt by replacing short-term securities with longer-dated ones.
- Mechanism: Market participants sell source securities to the Government of India and simultaneously buy destination securities at quoted prices.
 - € The process is executed through the e-Kuber portal via the Switch Transaction module.
- Benefits: Enhances debt sustainability, Bond Market development, > etc.



Fast Patrol Vessel (FPV) Achal

Fifth FPV Achal built by Goa Shipyard Ltd Launched for Indian Coast Guard (ICG)

It is the fifth FPV in a series of eight. >

About FPV Achal

- Its primary role includes protection, monitoring, control, and safeguarding offshore assets and island surveillance territories.
- It is designed and constructed under stringent dual-class certification from the American Bureau of Shipping and Indian Register of Shipping.
- It is aligned with the vision of Atmanirbhar Bharat in defence > manufacturing with 60% indigenous contents.

Rinderpest

ICAR-National Institute of High Security Animal Diseases (NIHSAD), Bhopal recognized as a Category A Rinderpest Holding Facility by the World Organisation for Animal Health (WOAH) and UN FAO.

ICAR-NIHSAD is a research institute on exotic & emerging pathogens of animals, & WOAH reference laboratory for avian influenza.


About Rinderpest (Cattle Plaque)

- It is a contagious viral disease affecting clovenhoofed animals > (mainly cattle & buffalo).
- Caused by: A virus of the Paramyxoviridae family, genus Morbillivirus.
- Severity: Spread by effective contact (does not affect humans) and may also lead to **death**.
- Infected animals on recovery acquire lifetime immunity.
- This is the second infectious disease to have been eradicated from the world after smallpox.
